





Strategic Prevention Framework (SPF)



5 Steps of the SPF

Step 1. Assessment—Discover what your community needs

Step 2. **Capacity Building**—Find out what your community needs to address identified problems

Step 3. **Planning**—Develop a detailed plan that links desired outcomes to identified needs.

Step 4. **Implementation**—Put your plan into action by delivering tribal best practices and evidence-based interventions.

Step 5. **Evaluation**—Assess the effectiveness of your prevention efforts.

Principles of the SPF

- Prevention is a continuum
- Prevention is prevention is prevention
- Successful prevention decreases risk factors and enhances protective factors
- Prevention strategies should use proven practices within systems that work.
- Systems of prevention services work better than isolated efforts



Gathering Of Native Americans



Elements/Stages of GONA

The four elements of the GONA/GOAN curriculum incorporate the values of human growth and responsibility that are found in Native cultures.

BELONGING A place for all ages. A place for all kinds of people. The first stage represents infancy and childhood, a time when we need to know how we belong.

MASTERY Empowerment, for individuals, and for the community. The second stage honors adolescence as a time of vision and mastery.

Elements/Stages of GONA, continued

INTERDEPENDENCE Action and community leadership. The third stage is symbolized by adults, integral and interdependent within their families and communities.

GENEROSITY Teacher/Elder and resources in the community. The final stage honors our elders, who give their knowledge and teachings to our future generations.

Principles of GONA

- Capacity building
- Community healing IS prevention.
- Healthy cultural traditions ARE prevention
- Holistic approach to wellness, interconnectedness, and interdependence was traditionally ingrained in Native belief systems (Balance and Harmony)


Principles of GONA, continued II

- Present a correct history of the important role Indigenous peoples play in American history, culture, and government
- Examine the historical trauma that impacts our struggle and recovery today
- Effective prevention must include whole community. Everyone is of value and has a role in the community healing process.
- Influence and empower individuals to understand the importance of their involvement

Principles of GONA, continued III

- Honor, respect, and incorporate ceremonies, rituals, and spiritual teachings of the people, "honoring the purpose of life."
- Effective prevention provides a means for feelings and healings to translate into actions/healthy behaviors .
- Creation of a safe place, forum, and format for communities to share, heal, and dialogue.



Considerations for the SPF: Assessment

- · Create a safe and welcoming space
- Avoid technical jargon
- Focus first on community assets, and gifts, then needs and issues
- Use focus groups or informal interviewing- Talking Circles
- Ask the community experts and wisdomkeepers about most pressing challenges



2. Capacity Building




Considerations for Capacity Building

- Resource + Readiness = Capacity
- · Recognize there is a need to create change
- Leadership training
- Communications/Decision making
- Treated as knowledgeable stakeholders
- Strengthen Connections



- Recognize youth and elders as valuable resources in creating relationships with the community
- Doing our best with what we have right now where we are




Planning & Community Involvement

- Encourage community experts to help identify and prioritize risk and protective factors
- Develop a culturally appropriate logic model
- Community experts lead in selecting culturally appropriate activities and interventions



4. Implementation



Implementation

- Community experts need to take the lead in designing, selecting, and taking part in the implementation of any community- or village-focused action plan
- Ensure a good match of facilitators and community advocates
- · Nurture relationships based on the "good relative" concept
- Be mindful of selecting appropriate culturally responsive interventions and activities

- Traditional Healing Ceremonies
- Tribal Crafts
- Songs & Dance
- Coming of Age
- Traditional Games
- Clans & Societies
- Storytelling
- Culture Camps



5. Evaluation



Culture-Based Evaluation and Giving Back

- Provide community-level training on how to:
- Facilitate "talking circles" to help assess and evaluate the impact of program activities
- Help conduct surveys and interviews during and after (process and outcome)
- Share in observations, analyses, conclusions, and recommendations for improvement and change
- Share findings with policy makers, tribal councils, founders, and community stakeholders

Cultural Sustainability Consists of...

- Attitudes
- Knowledge
- Skills
- Policies
- Capacity



- ...All of which enable prevention advocates to honor, respect, and effectively serve individuals and communities
- And with the 7th generation in mind

Reminder that Cultural Competence is...

Having the capacity to function effectively as an individual, organization, or a system within the context of the cultural beliefs, behaviors, and needs presented by the community and its members



Sustainability: Creating Communities of Collaboration

- Create a Safe Space
- Norms/Agreements for meaningful communications?
- Transparency
- Connectedness and trust
- Recognize and appreciate uniqueness



Sustainability

- Build support from the beginning
- Create ownership
- Identify program champions
- Invest & build capacity
- Identify diverse resources
- Seek and secure resources from diverse sources



Culture is Prevention

Connectedness to culture is the foundation for building and increasing protective factors, reducing risk factors
