Overview of the Technology Transfer Centers (TTC)



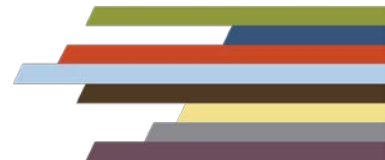
Purpose of the TTC Program

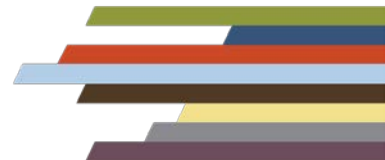

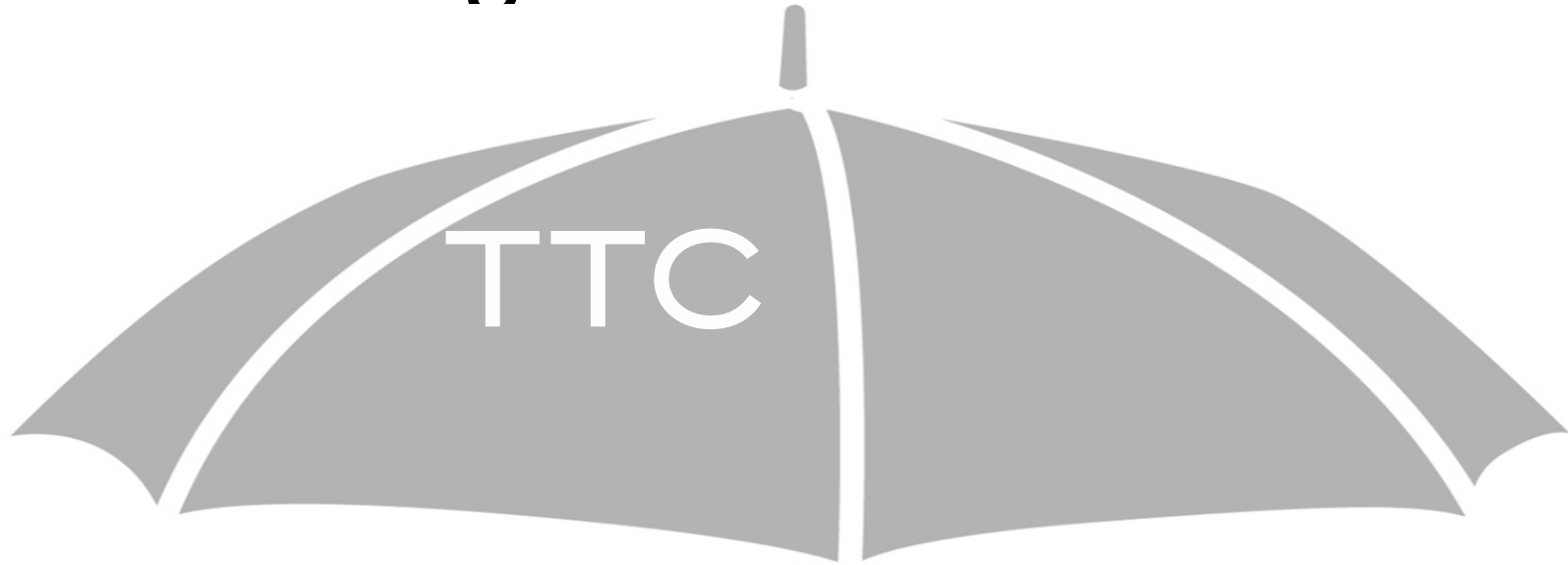

TTC Program Structure



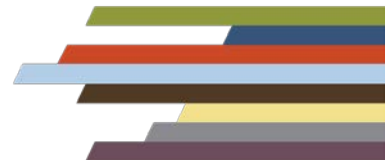

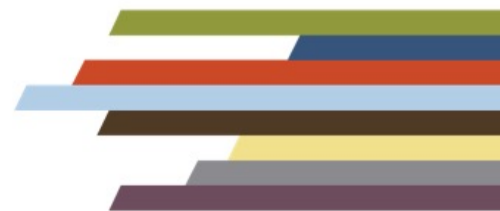

Great Lakes PTTC Cooperative Agreement

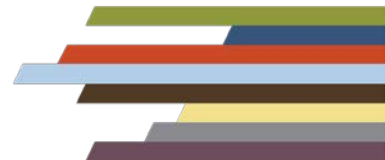
- Five-year cooperative agreement with the Substance Abuse and Mental Health Services Administration

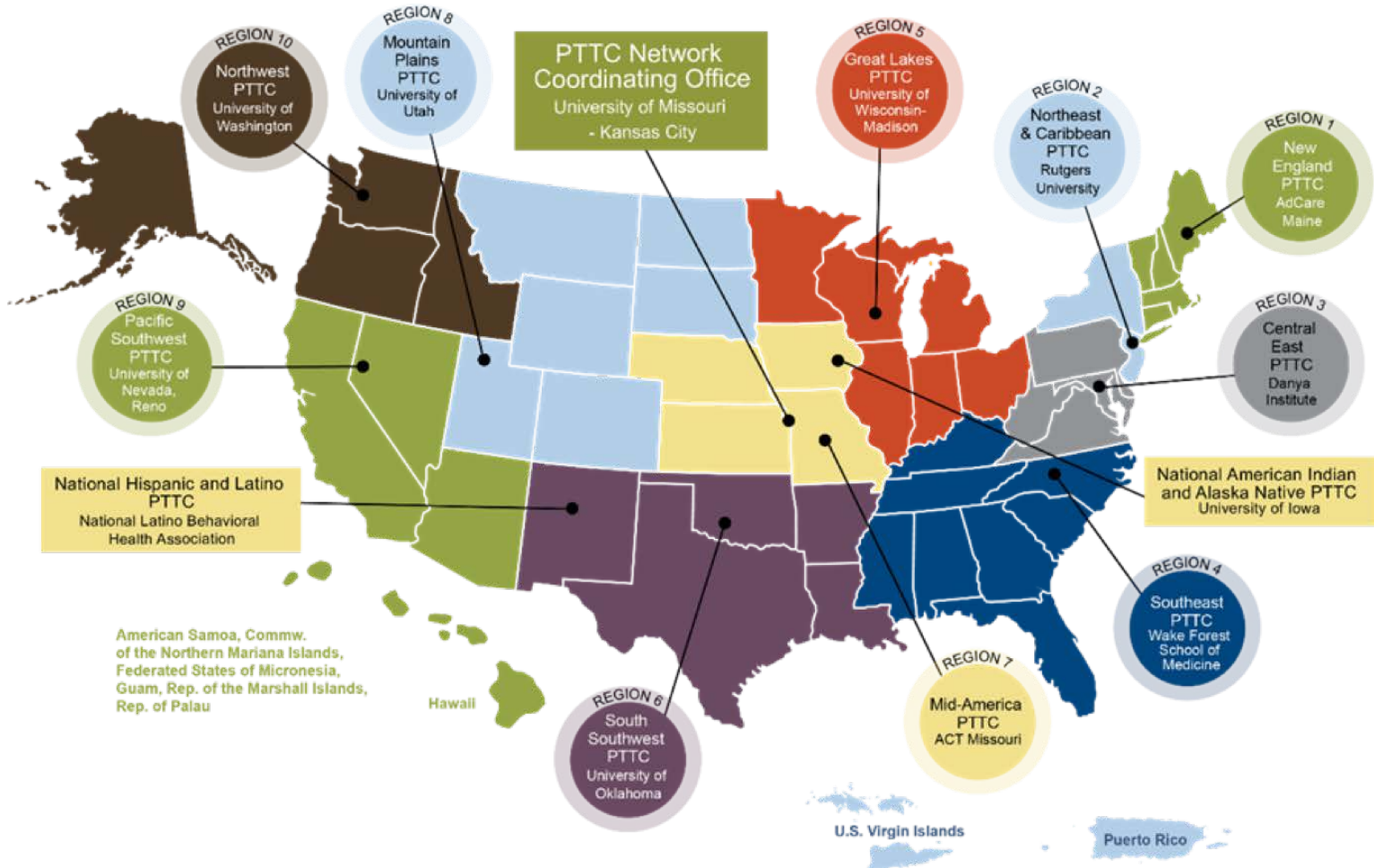
PTTC Map

Purpose of the PTTC Network

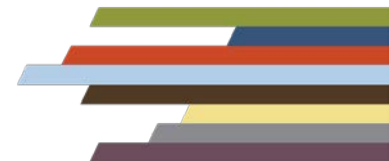
- **Improve implementation and delivery** of effective substance abuse prevention EBPs

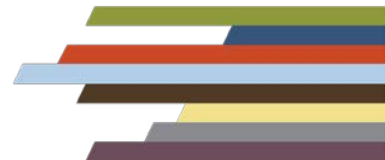

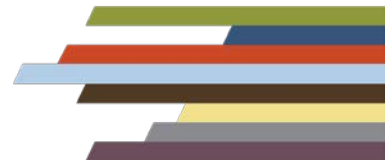

The UW-Madison: 3 TTCs

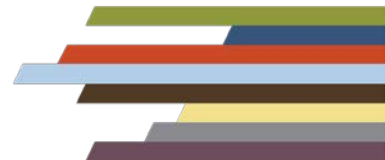
- The Great Lakes is one of two regions in the country that has all three TTCs under one umbrella at the UW-Madison

Great Lakes PTTC Goals

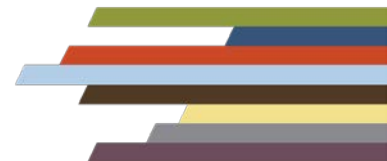
- Accelerate the **adoption and implementation** of evidence-based substance abuse prevention practices

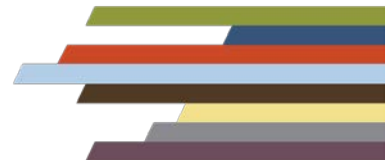
- A one-day face-to-face workshop on the NIATx model of process improvement, followed by three months of peer networking and support from a NIATx coach

A structured, team-based approach to change management that relies on the power of making small changes that produce results quickly.

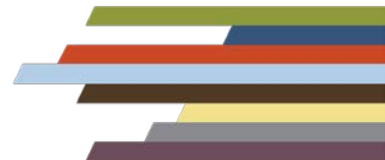
Participants learn how to:

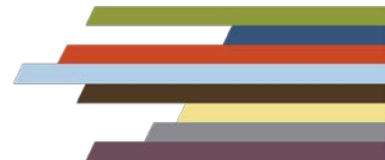
Great Lakes PTTC Process

 - For mental health, substance use disorder, or prevention best practices



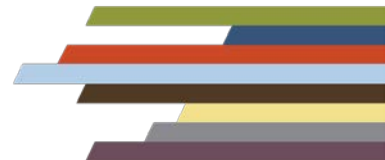

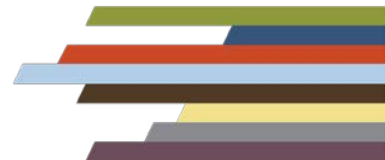

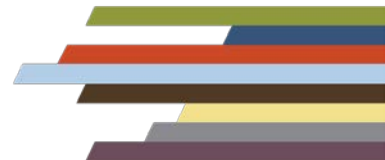
Prevention & State Project Managers

Great Lakes PTTC: Our Process

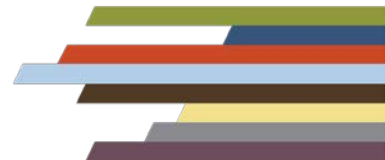
- The PTTC model differs from SAMHSA's previous model of delivering TA via CAPT.

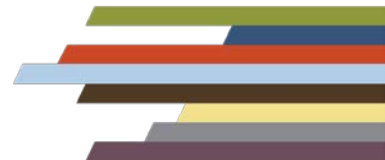
- The Great Lakes PTTC workplan will be implemented based on consulting a continuous needs assessment process:
